### Wiltshire Emigration Society

The Wiltshire Emigration Society was set up in 1849 on the initiative of Lord Bruce, later 2<sup>nd</sup> Marquis of Ailesbury. Most of the 258 sponsored emigrants came from the Savernake Estate and villages south-east of Marlborough. They were sent on six ships, four to Adelaide and two to Port Phillip, between March and June 1851.

## 34 Sir Charles Hobhouse

Sir Charles Hobhouse, 3<sup>rd</sup> Baronet, was the son of Henry Hobhouse (1791-1868) and his wife Mary Anne. Mary Anne Hobhouse was the daughter of the Calcutta merchant John Palmer (1767-1836).

Thomas Courtenay (London) to Robert Scott, 15 Jan. 1827: has decided to appropriate £40,000 for property owners in Bencoolen who have suffered from the transfer to the Netherlands Government. (copy)

Memorial of the proprietors of spice plantations and other property at Bencoolen in Sumatra to the Board of Commissioners for the Affairs of India, n.d. (copy)

Robert Scott (London) to India Board, 20 Jan. 1827: £40,000 seems inadequate compensation for the ruin which has resulted from the transfer. (copy)

Memorial from the proprietors of spice plantations and other property at Bencoolen to the Court of Directors of the East India Company, 28 Feb. 1827. (copy)

J.S. Brownrigg (London) to John Palmer, 28 march 1827: refers to some progress with the difficulties of the Bencoolen settlers. (copy)

John Palmer (Calcutta) to J.S. Brownrigg, 8 April 1827: difficulty with the bills of Dutch companies and the Java Government. (copy)

John Palmer to Henry Hobhouse, 1 Sept. 1827: personal and business news.

John Palmer (Penang) to his son Samuel Palmer, 9 Nov. 1827: ill health; trouble with his eyes.

John Palmer (Malacca) to Samuel Palmer, 19 Nov. 1827: improvement in his health.

John Palmer (Singapore) to Samuel Palmer, 25 Nov. 1827: his health; trouble with eyes; news of friends.

Business correspondence, mostly sent from Antwerp to J. Barnaby (Samarang) on trade in various commodities, including coffee and spices, 1825-27. (In Dutch and English)

Lt. Col. Nahus (Maastricht). The causes of the Java War, Feb. 1826 (29pp), with an addendum (13pp) written at Surakarta (Java), 4 Jan. 1828.

John Palmer (Batavia) to Samuel Palmer, 24 Jan. 1828: family news; plans to visit Solo (Surakarta); restoration of health.

J.S. Brownrigg (London) to John Palmer, 30 Jan. 1828: Bencoolen planters; Java Government bills and other matters.

John Palmer (Solo) to Samuel Palmer, 14 Feb. 1828: family matters; the rebels; when rains subside will move in small detachments between the insurgents and the Hollanders.

R.C. Jenkins (Calcutta) to John Palmer (Penang), 30 March 1828: family news.

M.O. Hunt (Surabaya) to John Palmer (Batavia), 19 April 1828: commission business has dwindled away to nothing; a business proposition.

John Palmer (Nagulan) to Samuel Palmer, 30 April 1828: plans for return to India.

Charles Cockerell (London) to John Palmer, 23 May 1828: refers to Dutch bills.

J.S. Brownrigg (London) to John Palmer, 13 June 1828: affairs.

John Palmer (Batavia) to Samuel Palmer, 13 June 1828: expects to return at the end of the month.

John Palmer (Singapore) to Samuel Palmer, 27 July 1828: on his way home.

J.S. Brownrigg (London) to John Palmer, 15 Dec. 1828: Java Trust Account distribution to the Bencoolen planters.

John Palmer (Calcutta) to Samuel Palmer, 16 Feb. 1829: domestic and other news.

J.S. Brownrigg (London) to John Palmer, 8 May 1829: refers to Javanese matters. (copy)

John Palmer (Calcutta) to J.S. Brownrigg, 22 May 1829: plans to discharge himself of all substantive acts of the House except for transactions on Java; history of the failure of the House. (copy)

Thomas Bate was a clerk on HMS *Iron Duke* (Capt. William Arthur), the flagship of Admiral Charles Shadwell, the Commander-in-Chief of the China Station.

Bate (Plymouth) to his aunt, n.d.

Bate (Malta) to his aunt, 8 Sept. (Oct.?) 1871.

Bate (Bay of Biscay) to his aunt, 18 Sept. 1871.

Bate (between Aden and Trincomalee) to his aunt, 16 Nov. 1871.

Bate (towards Singapore) to his aunt, 8 Dec. 1871, with a brief addendum at Singapore, 17 Dec. 1871.

Bate (Selangor) to his mother, 27 Dec. 1871: impending departure for Penang; has been in action; Selangor a nest of pirates; account of fighting; family news; his engagement; stay at Singapore; its excessive heat.

Bate (Singapore) to his aunt, 13 Jan. 1872: pleasant stay at Penang; first flagship to visit Penang in 16 years; social activities; painting of *Iron Duke* destroying a fort at Selangor; fears of a general rising of Malays in Sumatra and the Straits Settlements; visit to Sessions House in Singapore.

Bate (at sea) to his aunt, 28 Jan. 1872: English news; improvement in weather; monsoons; fears of a long stay in Hong Kong, a 'fever hole'; visit to Manila. Addendum of 20 Feb. 1872 refers to sighting of Victoria Peak, Hong Kong.

Bate (Hong Kong) to his mother, 3 March 1872: Hong Kong preferable to any other place on the Station; succession of entertainments; foreign ships in the harbour; domestic economy of the Chinese; impressions of Hong Kong.

Bate (Woosung) to his mother, 12 May 1872.

Bate (Woosung) to his aunt, 17 May 1872.

Bate (Nagasaki) to his aunt, 28 May 1872.

Bate (Yokohama) to his mother, 15 July 1872.

Bate (Chefoo) to his aunt, 20 Sept. 1872.

### 865 Papers of Chafyn Grove Family of Zeals, Wiltshire

570 Diaries of William Chafyn Grove, 1819-65

William Chafyn Grove (1840-1865), the son of William Chafin Grove of Zeals House, was educated at Eton and Trinity College, Cambridge. He was an ensign and lieutenant in the Coldstream Guards. He died at Poona, India, on the return journey from Australia.

Select:

Diary (no. 9) kept by William Grove on the voyage to Australia on the *Vimiera* and while travelling in New South Wales, Victoria and Tasmania, 2 October 1864 – 11 November 1865. (201pp)

The first part of the diary describes the voyage of the *Vimiera* from Plymouth to with references the weather, winds and seas, fellow-passengers, sightings of other ships, Crossing the Line ceremonies, sightings of dolphins, albatrosses and other birds and fish, theatrical performances, views of the New South Wales coast and his arrival at Sydney (13 Jan. 1865)

The following entries record Grove's impressions of Sydney, harbour cruises, visits to the Botanic Gardens, meetings with local residents including Frederick Darley and his family, a dinner party at Government House, a Melbourne-Sydney cricket match, and a visit to Parramatta. On 11 February Grove left Sydney and sailed to Melbourne and Launceston, spent a few days in Tasmania, and then made short visits to Melbourne and Ballarat before returning to Sydney on 3 March. In March and April he travelled with his friend H.W. Hoffman into the interior of the colony, visiting Wollongong, Kiama, Gerringong, the Blue Mountains, Bathurst, Sofala and Mudgee. On 10 April they reached Llangollen Station, near Cassilis, where they stayed for nearly four months. There are references to the work of the station, shearing, stock movements, regular visits to the home of William Busby and to Collaroy Station, the home of Rowland Traill, reading, visitors, news from England, the New South Wales Land Bill, the deaths of the bushrangers Ben Hall and John Gilbert, and news of the American Civil War. Grove left Llangollen on 30 April and journeyed to Singleton, Muswellbrook and Newcastle, finally arriving in Sydney on 3 August. In his final month in the colony he made a short visit to Newcastle, attended a ball at Government House, inspected the University of Sydney, and met notable colonial figures such as Sir William Manning, William Macleay and Edward Merewether.

Grove left Sydney on 22 September 1865 and sailed on the SS *Northam* to Point de Galle, Colombo, Kandy and Bombay. The last entry was written on 11 November, four days before his death.
